AWARD NOTIFICATION

Applications will be reviewed by a scholarship committee. The minimum award is \$1,500. Scholarship **winners** will be notified by April 15th via email and/or postal mail. Winners will also be posted on the GFWC Illinois website.

If selected to receive a scholarship, the student will be required to send a letter of acceptance from the school the student will attend in the Fall 2026 semester. When winners are notified, complete information and the federation address will be included. Checks will be mailed and made payable directly to the college, university, or vocational school.
